8. Would you support mandatory diversity training that includes LGBT+ issues for public employees?

Yes, absolutely. Within the Party itself, I will see to it that that a top to bottom review is conducted with an analysis of where we need to augment, expand and/or establish a system that puts into place best practices adopted by organizations that have been more proactive with respect to LGBT+ issues.

And on another front, we ought to consider a 'Truth, Accountability, and Reconciliation' Commission for instance, to help all affected by the revelations of sexual assault, harassment and bullying that have recently plagued the Party. Many, if not most of the victims were LGBT+.

9. If your place of employment has diversity training, did you advocate for inclusion of LGBT+ issues? Why or Why not?

At Emerge, I was responsible for instituting cultural diversity and inclusion training as a permanent component of its curricula, making sure it was lead by LGBT+ activists. Jona Olsson, Director of Cultural Bridges to Justice, provided programs which addressed confronting the systemic oppressions in our personal lives and within organizations or institutions. Nearly half the program was about confronting challenges and injustices experienced by the LGBT+ community.

10. Would you support mandatory diversity training for all law enforcement, including correctional peace officers, that includes LGBT+ issues?

Absolutely, without a doubt! Bigotry, discrimination, insensitivity, indifference and ignorance against members of the LGBT+ community has resulted at times in tragic and unacceptable outcomes. Not only should there be training, but anyone who is found to have engaged in such behavior needs to held accountable.

11. Do you support marriage equality (laws permitting same-sex couples to marry under state law?

Yes, of course. It's sad the question has to be even asked still.

12. Did you publicly oppose Proposition 8? If not, has your position evolved?

I publicly opposed Prop 8.

13. Do you support laws enabling individuals, such as property owners, businesses and government officials to disregard LGBT+ rights, such as marriage, employment or housing, on the basis of personal or religious belief exemptions?

14. Do you support an age-appropriate public school curriculum that teaches awareness and sensitivity regarding sexual orientation and gender identity?

Yes! It is vitally important that we do all we can to show LGBT+ children and young people that we are there to support them. Sexuality is a part of being human and without inclusion of a curricula and overall awareness that demonstrates their inclusion, they will never feel as 'normal' as cisgender identities - and this carries over into society. Fear of harassment and bullying, fear of how friends or family might react, are all the more reasons why schools and teachers have an important role to play, so that LGBT+ kids can do well, feel valued and empowered, and do better as students and later as adults, in life.

15. Do you support protections for transgender, gender non-conforming and questioning youth, regardless of sexual orientation, from discrimination in schools, foster care, juvenile justice and other institutional settings, including personnel training and zero tolerance for disparagement by peers?

Yes, and for the reasons given at the end of the last question. It's heartbreaking that in a society that is so technologically advanced that we still have archaic attitudes about humanity.

16. Do you support protections for transgender individuals covering areas such as name-choice, facilities access and work place rules (e.g., non-discriminatory dress codes)?

Yes, absolutely.

17. Do you support requiring health insurance companies to cover medically necessary gender reassignment surgeries and follow-up care for individuals identifying as transgender?

Yes, and I am proud of the fact that one of my campaign staff was instrumental in getting a resolution passed by the CDP which called on the Party to support it.

18. Do you support allowing transgender Americans to serve in the U.S. military?

YES! An estimated 15,000 or more serve in the military, but since the Supreme Court's vote siding with President Trump to lift the lower court's injunction against a ban which bars transgender from serving, how else can we see this other than an attack on all transgender in our nation? The consequences are ugly and backward: going back in the closet, greater danger to trans soldiers who have to fear for their health and safety, abuse, discharge for reasons they should never have to suffer and most of all, another signal that society doesn't accept them.

19. Do you support <u>local funding</u> for HIV/AIDS services, including, but not limited to, needle-exchange programs?

Yes.

20. Do you support the rights of women to access reproductive healthcare, including abortion?

Yes. The right to reproductive healthcare has been the hallmark of the Women's movement for decades. Now in the era of Trump, we are seeing the denial of reproductive healthcare as a central weapon in the attack against working class families and recognition of equal rights. We have seen that women's reproductive rights are under attack. Many states have passed burdensome and restrictive laws to prevent women from exercising their constitutional right to choose. And we have also seen the extreme lengths Republicans in Congress will go to appoint anti-choice judges to the Courts.

The times call for a massive and deep commitment to an organizing approach if we are to save our hard fought rights and finally realize a constitutional amendment guaranteeing equal rights for all. including making it clear that reproductive rights are human rights.

21. Do you support comprehensive immigration reform, including a path to citizenship?

To underscore my agreement with our state party's platform, I believe we must establish an immigration policy that stops the criminalization of communities of color and keeps families together. Since it is a fact that over 85% of undocumented immigrants have resided in the U.S. for over 5 years, we should expand President Obama's DACA (Deferred Action for Childhood Arrivals) program accordingly, so we can provide relief for those children who arrive to our country unaccompanied as well as the DREAMers; and for the parents of citizens, legal permanent residents. and others who have no such protections under current law.

The nation and world witnessed the astounding cruelty of Trump's zero-tolerance policy as traumatized and crying children were ripped from the arms of their parents and then placed in internment camps. A January 2019 report by the Office of Inspector General for the Department of Health and Human Services states that the total number of children who were separated will probably never be known, or if all of them can ever be reunited with their families. The thought of such a thing is unimaginable, but the nightmare is that in fact, it's a reality. Though a federal judge ordered HHS to identify and reunite all separated children and to stop the separations in June 2018, an 118 additional children were separated from their families.

In addition to the inhumane policies at our Southern border, ICE's deportation programs have unjustly turned local law enforcement into immigration enforcement officers. As it's currently constituted, we must abolish ICE, demand the resignation of Secretary Nielson and call to account, anyone who was involved in the implementation of this cruel and morally repugnant policy.

22. Please describe your top goals, if elected to office.

As Chair of the California Democratic Party, there are four specific priorities for the remaining two years of the term:

- 1. (Hold Electoral Gains from 2018) While there were certainly incredible gains in the 2018 midterms, specifically in traditionally Republican congressional districts, it will be unlikely that California Democrats retain these seats without tremendous investment by the CDP in infrastructure, as well as expanding coalition building with affinity groups like Our Revolution and others - partnerships that were critical in picking up these seats in 2018.
- 2. (Prepare for 2020 Presidential Primary) California's new oversized role on Super Tuesday has certainly changed the stakes for California Democrats. It's critical that our State Party ensures a fair playing field for all contenders and ensures that our Party remains whole after what is expected to be a hotly contested primary. California Democrats also need a Chair who can leverage California's new found heft on the national political stage to steer policy conversations towards the values articulated in the CDP's platform, such as Medicare-For-All and for the Green New Deal.
- 3. (Take Back White House) California Democrats have additional work to do in maintaining our seats and expanding our representation at the local, state and federal levels. And while the work of the State Party should being focused on building the bench at the local levels and state races and ballot measures, California must also ensure that our resources and efforts are put to strategic use in taking back the White House in 2020.
- 4. (Culture Change) Most pressing for the CDP is addressing the toxic culture and managing the pending litigation and public relations challenges. The CDP is in shambles with respect to legal Kumberly

liability, leadership vacuum, fundraising and public reputation. It's critical that we address the toxic culture that created these issues and build an organization that is inclusive and safe for all.

Finally, I am committed to the original vision I laid out for the CDP when I first ran in 2017. I am committed to getting our Party back to basics through organizing and investing in people, as well as expanding and democratizing our Party structure, as well as ensuring sound, progressive policies like SB562 get signed into law.

24. Please describe how your election to this office would benefit the LGBT+ community.

I have the professional and life experience of changing existing culture in the places I have worked – I will be comfortable in doing the same for the better in the CDP. This party should be about the delegates and those who look to our party (in all their diversity) for inspiration and vision to help enact a progressive agenda in our state. The California Democratic Party can set the standard for the rest of the nation and should, especially when we know from every day occurrences that anti-LGBTQ sentiments still motivate the hatred of an extreme religious right wing agenda.

Under my administration, a Head of People and Culture can shepherd a new era of training and accountability by first establishing channels of communication, then seeing to it that the importance of comfort and safety for all party members, employees and volunteers are made known throughout the party, down to the local level. A delegate handbook with 'rules of the road' and expected behavior articulated in plain language is a good start, as well as diversity and inclusion education and training at every level of our party.
